Family fortunes

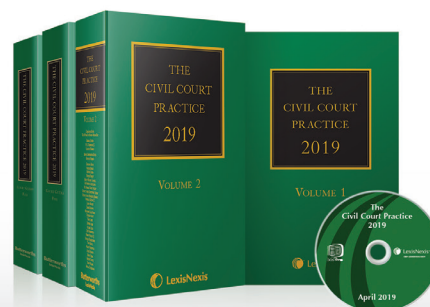
